### 6. Rate Proposal

We customarily divide our invoices according to general areas of practice, e.g. labor and personnel, student matters, retainer, special education, etc., and our time and billing system can adjust to Plum Borough School District's accounting needs or preferences.

Our approach to cost containment, while providing high quality legal services, includes:
