

RESOLUTION

A RESOLUTION OF THE PLUM BOROUGH SCHOOL DISTRICT, ALLEGHENY COUNTY, PENNSYLVANIA, CLARIFYING THAT THE LOCAL SERVICES TAX ("LST") LEVIED UPON PERSONS ENGAGING IN AN OCCUPATION WITHIN PLUM BOROUGH, PA SHALL BE COLLECTED BY PLUM BOROUGH EARNED INCOME TAX COLLECTOR OR ITS APPOINTED TAX COLLECTOR IN ACCORDANCE TO THE LOCAL TAX ENABLING ACT.

WHEREAS, the Board of Directors desires to clarify that it is the Plum Borough Local Earned Income Tax Collector to collect or appoint a tax collector to levy the Local Services Tax pursuant to Act 7 of 2007, known as the Local Tax Enabling Act.

NOW, THEREFORE BE IT RESOLVED by the Plum Borough School District that the Local Services Tax (LST) levied upon persons engaging in an occupation within Plum Borough shall be collected by _____ (name of municipality/borough(s)) or its appointed tax collector) in accordance with the Local Tax Enabling Act, Act 7 of 2007.

All Resolutions or parts of Resolutions which are inconsistent herewith are hereby repealed. The following Resolution or parts thereof are specifically repealed; and

If any section, clause, provision or portion of this Resolution shall be held invalid or unconstitutional by any court of competent jurisdiction, such decision shall not affect any other section, clause, provision or portion of this Resolution so long as it remains legally enforceable minus the invalid portion.
