Note: Net collection method will be used for the distribution of funds to the District.

- Approve the exoneration of the Current Real Estate Tax Collector for 2011 property taxes, per the delinquent property tax list (CD). Mr. Harry Schlegel has turned over uncollected property taxes amounting to \$ 990,017.91 for collections by Andrews & Price, Delinquent Property Tax Collector. The collection variance is \$993.33 (.000999%), due to rounding and negative Homestead / Farmstead exclusions. See Attachment #3
