## **Accomplishments**

- Complimented teachers for their effective incorporation of professional learning communities in planning lessons and making curricular decisions.

- Continued to include low-level, high interest AR books at lunchtime previewing to encourage special education students to increase reading and to take AR tests that will help them achieve the levels in Team Read while also improving comprehension.
- Encouraged special education teachers to continue brainstorming ways to provide an optimal environment for PSSA testing of the target group.
- Met with teachers to determine optimal scheduling of reading and math PSSAs and using snacks as an incentive to improve.
- Facilitated small group PSSA preparation during Activity Period for students in reading target group.
- Discussed with PASA administrators and involved teachers ways to ensure students taking the PASA will be prepared.
