The Western Pennsylvania Gasoline Diesel Fuel Consortium will be soliciting bids for gasoline, diesel fuel and heating oil for the 2015-2016 school year. As we move through the bid process, we will be exploring all options available to us to achieve the best pricing available in respect to market conditions. Fuel prices have been trending downward, and we plan to go out to bid as soon as possible. The attached Authorization Form, Usage Information Form and Tank Information Form must be completed and returned in order to participate.

- Gasoline, Diesel and Heating Oil Authorization Form for the 2015-2016 School Year. By submitting and signing this authorization form, you are committing your school district to participate in the consortium for the 2015-2016 school year.
- Gasoline, Diesel and Heating Oil Usage Information Form for the 2015-2016 School Year. By submitting and signing this usage form listing your districts monthly usage, you are committing your school district to participate in the consortium for the 2015-2016 school year.

Usage information must be listed in gallons by <u>month</u>. Please be sure to be as accurate as possible with your <u>monthly</u> gallons needed. The monthly gallons listed on your usage form will be purchased by the vendor who is awarded the bid for each month through the 2015-2016 school year.

The gallons you list must be ordered and delivered for each month. Depending on market conditions, if you order less than your committed gallons, the vendor may face penalties for the shortages which in turn may be passed on to your school district. If you order more that your committed gallons, you may be invoiced an increased rate for the additional gallons ordered. There is a 10% plus or minus allowance per month.

<u>Gasoline, Diesel and Heating Oil Tank Information Form</u> for the 2015-2016 School Year.
 This information will be needed by vendors interested in submitting a bid.

If you have a contractor providing bus service to your district, we suggest sharing this information with them before submitting these forms to us. Also, we suggest that you have this information approved by your Board before submitting these forms to us.

In order to participate in the bid process, the Authorization Form, Usage Information Form and Tank Information Form must be submitted via email or fax by November 21, 2014.
