- 1. Construction Updates
 - Public Works and Municipal Building property:

4. LERTA

A brief discussion occurred regarding several businesses that moved into the Borough. None of the businesses moved into a LERTA zone or are eligible for the tax abatement. The Committee discussed Borough and District tax base and taxes of other comparable communities. Opportunities for community development and quality of life improvement followed.

- 5. Delinquent EIT collection

The Borough selected Keystone for 2012 and future EIT delinquents and LST for 2014. The District will follow suit and discuss at the January Finance meeting.

6. Old Pivik School, Old Holiday Park School, and Bus Garage improvements and relocation

Significant discussion occurred revolving around cooperative arrangements for properties and public use. Individuals expressed interest in the properties being used for parks, fields and/or playgrounds. The Borough conducted two surveys to gauge community needs and interest. The lack of recreational and shopping opportunities was a common theme. The possibility of utilizing space at the new public works property for a transportation garage and facilities department was discussed.
