Agenda Items:

- A. Multi-purpose field & community sports complex
 - a. Foundation Trustee appointments were discussed. Mr. Alpino will schedule a meeting in April to set direction.
 - i. District Representatives – Bob Alpino, Sue Caldwell & Michelle Gallagher
 - ii. Borough Representatives – John Anderson, Joe Fischetti & Dave Seitz

- B. Larry Mills Soccer Field usage/agreement & Community Days
 - a. Discussion occurred regarding use and Sunday stadium use. The Larry Mills Fields are under construction and Plum Youth Soccer's request is unique due to the additional growing season required for field upgrades.
- C. Plum Borough Municipal Authority rate increase
 - a. The District raised concerns about the flood mitigation tax, rate increase and usage fee change that amounts to an annual increase of \$96,000 or 57%. The Borough will reach out to the Water Authority for assistance.
- D. School Road from one-way to two-way
 - a. The cart path width, traffic study and line of sight issue make the decision to keep School Road one-way most prudent, at this time.
 - b. Consider reaching out to Allegheny Council for Old Leechburg Road at New Texas Road bridge replacement.
 - c. We will investigate renewing our traffic study.
- E. Use of Council Chambers for Board meetings
 - a. Board and Council will discuss at respective meetings and plan to begin in

May 2105.

- F. Milltown Road – letter to state
 - a. Several weeks ago the Borough received information that a road project is forthcoming. More information will be available in the future.
 - b. Board members will reach out to state legislators.
- G. Top 10 Scofflaw offenders
 - a. The Borough staff is (re)constructing a list the top 10 - 15 properties based on dollar figures owed and liens against. More information should be available in the next month or two.
- H. SRO pension reimbursement
 - a. State reimbursement is approximately \$8000 per officer. The Borough's net cost is the amount split 70/30 according to our cost sharing.
- I. SRO MOU
 - a. The agreement expired in January 2015. The expired agreement states that the District pays 70% of the total package and the Borough pays 30%.
 - b. The District is asking for a 50/50 split.
- J. Trash/Recycling & Hauling bid combination
 - a. Borough has already awarded the bid to Allied Republic for dumpster service. The District will reach out the solicitor to investigate the legality of "piggybacking".
- K. Public zoning meeting
 - a. A public meeting is scheduled for April 4th at 6:00pm to discuss the Miranda plan development of 200 houses behind the S&T bank.
