TITLE I NON-PUBLIC SCHOOL CONTRACT Between PLUM BOROUGH SCHOOL DISTRICT and

ALLEGHENY INTERMEDIATE UNIT

This agreement is made and entered into as of the 2nd day of September 2015, by and between Plum Borough School District (hereinafter referred to as the "School District") and the ALLEGHENY INTERMEDIATE UNIT, AIU.

1. TERM

The Term of this Agreement shall commence on September 2, 2015 and terminate on June 30, 2016.

2. DESCRIPTION

Upon the terms and conditions set forth herein, School District requests that the AIU provide remedial **reading and math** instructional services in with the Title I Program at **Mother of Sorrows**.

The School District and the AIU agree to pool funds for instruction in the private schools. The pooled funds are used to serve the private school students most at risk who reside in participating public school attendance areas regardless of the amount of funds that was generated based on the number of children from low-income families attending that private school.

3. FEES AND PAYMENT

3.1 In consideration of the services mutually agreed upon as described herein, School District shall pay the Allegheny Intermediate Unit \$787.79 for Non-Public Title I Instruction as determined by their per-pupil allocation times the number of low income private school children.

The School District requests that the AIU provide Non-Public Title I Parent Involvement services in accordance with Title I (no set-aside available).

In consideration of the **Non-Public Title I Summer School** services mutually agreed upon as described herein, School District shall pay the Allegheny Intermediate Unit \$19.04.

3.2 The AIU will provide invoices to the school district once in 2015 and once in 2016, with fifty percent being invoiced during each billing period. If the school district's allocation is changed after PDE releases the final Title I allocations during the term of this agreement, then the AIU will adjust the second set of

invoices in 2016 to reflect any changes. The school district will supply the AIU with a revision form to reflect any adjustments.

3.3 The school district agrees not to reduce its final Title I non-public school allocation by more than 10% of the original contracted amount using the salary differential method. This is to ensure the AIU's Title I non-public school services are not interrupted or altered after PDE releases the final Title I allocations.

4. ALLEGHENY INTERMEDIATE UNIT RESPONSIBILITES:

- 4.1 To provide instructional services by a highly qualified certified Reading Specialist / Elementary Education, as required by Title I
- 4.2 To use appropriate evaluative testing/screening procedures and materials
- 4.3 To provide the School District and the private school an outline of the local assessment plan
- 4.4 To provide small group supplemental **reading and math** instruction for eligible private school students
- 4.5 To assure all financial and legal responsibilities involved in providing the instruction:
 - 4.5.1 Pay salary and all benefits for the reading specialist
 - 4.5.2 Provide materials, which supplement regular instruction
 - 4.5.3 Provide diagnostic testing instruments
 - 4.5.4 Supervise the instruction
 - 4.5.5 Any other responsibilities necessary to conduct the program as intended
- 4.6 To require the AIU teacher to complete the following requirements in addition to providing the weekly instructional periods
 - 4.6.1 Conduct diagnostic and benchmark testing as needed on eligible private school students
 - 4.6.2 Maintain records of assessment data, instructional activities, and attendance for students served
 - 4.6.3 Meet with parents for conferences as requested

4.6.4 Provide progress report at the end of the year for each student served

4.7 To be responsible for the following:

- 4.7.1 Provide the School District with the addresses of the students served
- 4.7.2 Provide the School District with the data necessary to complete their Title I responsibilities including assessment data and related data.
- 4.7.3 Meet with private school administrators twice annually to review services provided to their students
- 4.7.4 Provide the School District access to the program at any time

5. SCHOOL DISTRICT RESPONSIBILITIES

- 5.1 Provide the AIU with names of private schools identified to participate in Title I
- 5.2 Assist the AIU in identifying addresses of students who reside in Title I attendance areas
- 5.3 Inform the Allegheny Intermediate Unit of any and all circumstances which may directly or indirectly affect the performance of this Agreement, including changes in the original funding allocation

6. MISCELLANEOUS

- 6.1 The Allegheny Intermediate Unit maintains and keeps in force such insurance as Workers Compensation, Liability, and Property Damage.
- 6.2 The Allegheny Intermediate Unit shall indemnify, defend, and hold harmless the School District from any and all losses, damages, claims or costs, including attorney's fees, arising from any act or omission of the AIU, its officials, agents, or employees.
