STEP #4: Organization's Responsibilities

- 1. Organization agrees that BGP will publish and distribute the exclusive sports poster for Organization.
- 2. BGP has exclusive rights to produce these materials and sell advertising to merchants around Organization's community.
- 3. Organization agrees to distribute the posters to the students, fans, parents, teachers, around the school and the community.

- 11. Organization agrees to provide BGP with key community supporter information. Organization also agrees to inform the public, the media, and any prospective advertisers, if contacted, that BGP has been authorized by your organization to produce the specified materials.

This agreement shall continue for future seasons unless written cancellation is received one season after the original term has been fulfilled and all advertising obligations have been fulfilled to advertisers for all campaigns started and for all seasons. Should Organization not fulfill this agreement, for any reason, Organization will forfeit their right to further rebate payments.
