<b>123. INTERSCHOLASTIC ATHLETICS</b>	
1. Purpose	<p>The Board recognizes the value of a program of interscholastic athletics as an integral part of the total school experience for all district students and as a conduit for community involvement.</p> <p>The program fosters the growth of school loyalty within the student body as a whole and stimulates community interest.</p> <p>The game activities and practice sessions provide opportunities to teach the values of competition, sportsmanship, and teamwork.</p>
2. Definition	<p>For purposes of this policy, the program of <b>interscholastic athletics</b> shall include all activities relating to competitive or exhibition sport contests, games or events involving individual students or teams of students when such events occur between schools within this district or outside this district.</p>

Authority <b>SC 1601-C et seq</b> Title 22 Sec. 4.27 34 CFR Sec. 106.41 Pol. 103, 103.1	<p>It shall be the policy of the Board to offer opportunities for participation in interscholastic athletic programs to male and female students on as equal a basis as is practicable and without discrimination, in accordance with law and regulations.</p>
SC 511	<p>The Board shall determine the standards of eligibility to be met by all students participating in an interscholastic program. Such standards shall require that each student, before participating in any interscholastic activity, be covered by student accident insurance; be free of injury; and undergo a physical examination by a licensed physician.</p> <p>The Board further adopts those eligibility standards set by the Constitution of the Pennsylvania Interscholastic Athletic Association.</p>

<p>SC 511</p> <p>Pol. 204</p> <p>Pol. 218</p>	<p>The Board directs that no student may participate in interscholastic athletics who has not:</p> <ol style="list-style-type: none"> <li>1. Met the requirements for academic eligibility.</li> <li>2. Complied with the requirements of the Code of Conduct for Interscholastic Athletics and Board policies and administrative regulations related to student discipline.</li> <li>3. Attended school regularly.</li> <li>4. Been in attendance on the day of the athletic event or practice for the hours required unless extenuating circumstances prohibited attendance. (Such as funeral, field trip, college visit, religious holiday).</li> <li>5. Returned all school athletic equipment previously used.</li> <li>6. Adhered to applicable discipline standards.</li> </ol>
<p>Pol. 218</p>	<p><u>Off-Campus Activities</u></p> <p>This policy shall also apply to student conduct that occurs off school property and would otherwise violate the Code of Student Conduct if any of the following circumstances exist:</p> <ol style="list-style-type: none"> <li>1. The conduct occurs during the time the student is traveling to and from school or traveling to and from school-sponsored activities, whether or not via school district furnished transportation.</li> <li>2. The conduct involves the theft or vandalism of school property.</li> </ol>
<p>4. Delegation of Responsibility 24 P.S. Sec. 5323, <b>5333</b> Pol. 123.1, <b>123.2</b></p>	<p>Each school year, prior to participation in an interscholastic athletic activity, every student athlete and his/her parent/guardian shall sign and return the acknowledgement of receipt and review of the <b>following</b>:</p> <ol style="list-style-type: none"> <li>1. Concussion and Traumatic Brain Injury Information Sheet.</li> <li>2. <b>Sudden Cardiac Arrest Symptoms and Warning Signs Information Sheet.</b></li> </ol> <p>The Superintendent or designee shall annually prepare, approve and present to the Board for its consideration a program of interscholastic athletics, which shall include a complete schedule of events.</p>

Guidelines</p> <p>SC 1603-C</p> <p>SC 1603-C</p> <p>SC 1603-C</p>	<p>The Athletic Director shall disseminate rules for the conduct of students participating in interscholastic athletics. Such rules shall be in conformity with regulations of the State Board of Education, the P.I.A.A. and the school district.</p> <p>The Superintendent or Athletic Director shall ensure that similar athletic programs are offered to both sexes in proportion to the district's enrollment.</p> <p>The Superintendent or Athletic Director shall ensure that interscholastic athletics are open to all eligible students and that all students are fully informed of the opportunities available to them.</p> <p><b><u>Male/Female Athletic Opportunities Report</u></b></p> <p><b>By October 15 of each year, on the designated disclosure form, the Superintendent or designee shall report to the PA Department of Education the interscholastic athletic opportunities and treatment for male and female secondary school students for the preceding school year.</b></p> <p><b>By November 1 of each year, the completed disclosure form shall be made available for public inspection during regular business hours and posted on the district's website.</b></p> <p><b>The availability of the completed disclosure form shall be announced by posting a notice on school bulletin boards, in the school newspaper, on any electronic mailing list or list serve, and by any other reasonable means.</b></p> <p>References:</p> <p>School Code – 24 P.S.
